Meanwhile the usual Foundation work continued including a review of the Board's administrative requirements, the redefinition of the staff role and search for a "Board Administrator." Barb Wright joined Brant Waterways in January 2019 and enthusiastically turned her attention to Foundation events and activities.

2018 was marked by significant activity and

developments on the TIRA campaign front including a community forum in Paris, ongoing consultation with stakeholders, the identification of potential projects, the formation of committees, the design and production of campaign literature and promotional material and the delivery of training/orientation sessions on campaign best practices. With systems and supports in place, Brant Waterways' Directors moved onto the "quiet phase" of the campaign involving the cultivation of prospective donors and partners to contribute to the ambitious \$1 million fundraising goal.

By late fall, local philanthropists Paul and Margot Williamson announced their \$100,000 commitment to TIRA! We are grateful for Paul and Margot's generous and visionary support and we are committed to building on this strong momentum as we work toward the successful completion of the campaign.

GWTN Trailhead Symposium

With financial help from Brant Waterways, the Grand Watershed Trails Network, in conjunction with the Ontario Trails Council, hosted a symposium to engage and educate Grand Watershed trail builders, user groups, land owners and other stakeholders and promote opportunities to build partnerships.

High School Tree Planting Day

Brant Waterways Foundation is a long-time supporter of the Brant Tree Coalition's Earth Week activities. On April 25, 2018 local high school students took part in a hands-on environmental remediation project involving the planting of 7,000 native trees and herbaceous plugs and the creation of pollinator meadows.

Grand River Shoreline Clean-up and Beautification at Chiefswood Park

In the second phase of a project led by Kayanase, a native plant nursery and ecological restoration company based in Six Nations, participants documented and removed trash along the shoreline at Chiefswood Park, planted native plants and grasses along the park shoreline and planted large caliper specimen trees at various locations throughout the park in an effort to increase its biodiversity.

Brant/Brantford Children's Water Festival

For the past 10 years, Brant Waterways Foundation has been a proud supporter of a three-day event led by the Grand River Conservation Authority. Every year more than 1,300 grade 4 students in Brantford, Brant County and Six Nations of the Grand River learn about the importance of water and water conservation through a series of fun and interactive activities. The goal of the festival is to promote awareness about water so that the children become catalysts for change and good stewards of our natural resources.
